APPLICATION DEADLINE: **Friday, July 24, 2009 (By close of business)**

AUDITIONS: Saturday, August 15, 2009 (Chapungu Sculpture Park at Centerra) at 8 a.m.

SHOW & JUDGING: Saturday August 22, 2009 between 11:30 a.m. and 1 p.m.
Old-Fashioned Corn Roast Festival (Fairgrounds Park, 700 S. Railroad Ave.)

ENTRY FEE: \$10 per entry (Late Fee: \$15 per entry after July 24)

<u>SCORING:</u>	Talent	50 points (Ability, expertise, skill, proficiency and practiced)

	Crowd Participation	<u>10</u> points (Crowd interaction, singing along, applause, and cheering)

1. Only individuals from Loveland/Northern Colorado who have been residents here for one (1) year or more are eligible to enter. The decisions of the judging panel and Talent Coordinator are final.
2. **Niblets:** 2 through 12 years. **Ears:** 13 through 17 years. **Cobs:** 18 years and up.
A person's age for the Old-Fashioned Corn Roast talent contest competition is determined at the time they participate at the Loveland's Got Talent AUDITION, August 15, 2009. For example, a 12-year-old (or 21-year-old) could turn 13 (or 22) by Corn Roast Festival and still be eligible in the Niblets (or Ears/Cobs) division, as they met age requirements at the time of audition.
3. No one under the age of 18 will be allowed to audition without signed consent from legal parent or guardian.
4. Average age of the majority of the group determines the category. Final Decision on category placement is determined by the Loveland's Got Talent Committee.
5. Four (4) finalists will be chosen at auditions per division and will be entered in the "Loveland's Got Talent" talent show during the Old-Fashioned Corn Roast Festival, Saturday, August 22, 2009. One (1) alternate will be chosen as a standby.

OLD-FASHIONED CORN ROAST FESTIVAL TALENT CONTEST RULES FOR CONTESTANTS - CONTINUED

6. Each act will run no more than three (3) minutes. Acts running longer than three (3) minutes may be disqualified. Set up time is not included, but is limited to one (1) minute.
7. No more than five (5) persons are allowed in an act. Piano accompanist is NOT included in an act and may be any age. No more than three (3) accompanists permitted per act. Drums, amps, etc. are discouraged due to the one (1) minute set-up time. No combos, rock bands or similar musical group permitted.
8. All contestants must be on the festival grounds one (1) hour prior to their scheduled stage time and must report to the Talent Coordinator at the main stage.
9. Contestants must use the same act as auditioned.
10. Please keep performance family oriented. Talent Coordinator has sole discretion to refuse any act.
11. Contestants must furnish any equipment needed for their act for both the audition and the final judging - if they place.
12. Groups must form a straight line on stage for introductions. Acts may not dance onto or off the stage. After introductions, you may take any position you wish to begin your performance.
13. No contestant may have live professional back up. Vocalists may sing with a pre-recorded tape or any type of pre-recorded electronic musical accompaniment. This includes pre-recorded accompaniment with an instrument (for example, keyboards with added rhythms or orchestration). Pantomime, lip sync, and karaoke are not allowed. Cassette tapes or CDs may be used as accompaniment for dance acts, baton, etc. Participants must provide their own CD or cassette recording equipment. Pure "mime" is accepted.
14. Contestants may only appear once in any given show. They may not perform "solo" and then return in the same show in a duet or trio. Contestants are allowed to perform in different acts in different shows, but they may only qualify for the Old-Fashioned Corn Roast Festival with one act.
15. Professionals are NOT permitted to compete. This includes Union musicians and anyone whose principle source of income is from their talent. Compensation for performing at weddings, etc., does not constitute principle source of income.
16. Only one trophy per winning act will be awarded. Additional trophies may be ordered and must be paid for by participants or guardians of participants of the winning act at the time they are ordered.
17. Each act must have its own entry form - one (1) application form per act. Groups should prepare a list of additional participants and attach it to the application. The \$10 entry fee applies to one (1) act and all participants within that act. All application forms must be complete to be valid. Multiple member acts need a single contact person with all information going through them.
